## Earl Cecil, Executive Director



After 31 years on the Board staff, first as Fiscal Director and the last twenty as Executive Director, it is time to pass the leadership of our System of Care on to a new generation. I have been reflecting on our system of care today, how it has changed since August 1979 when I was appointed to serve as a Board member from V inton County. There were eight agencies providing limited mental health outpatient services. Today we have agreements with 34 providers, agencies and community partners that are providing community based services, intensive outpatient services, residential treatment, psychiatric inpatient, housing, peer and recovery supports to the residents of our three counties and employing over a thousand dedicated staff helping those with mental health and addiction disorders.

Also, the public understanding and acceptance that mental illnesses and addictions are treatable brain disorder—that treatment and recovery supports work—and that people can improve their health and wellness and live self-directed lives has significantly changed over these years. With the continued support and collaboration of caring and supportive communities, elected officials, and forward-thinking providers, the Board will continue the work to building a person-centered System of Care, focused on the individual needs of the residents of Athens, Hocking and Vinton Counties.

### Alcohol, Drug Addiction and Mental Health Services Board (317 Board)

provides a *Network of Care* for mental health and addiction services to residents of Athens, Hocking and Vinton Counties. The Board assesses service needs, contracts with local service providers and evaluates performance via achieved outcomes. The Board primarily pays for services not reimbursable by Medicaid or health insurance and/or services received by persons without health insurance coverage. The Board works with community partners to ensure that individuals and families effected by mental illness or substance use disorders have access to high-quality prevention, treatment and recovery supports.

The Board held its Annual Meeting at the Hocking Hills Golf Club & Urban Grill on October 28, 2019 with approximately 70 in attendance. The Rita Gillick Mental Health Advocate Award was presented to Tracie Dearing and the Valeria "Taffy" Marks Substance Abuse Prevention Award was given to Bill Dunlap.

### SFY 2020 Highlights

Helping Those with Mental Illness-



Crisis Intervention Training (CIT) is a five-day training program for area law enforcement officers and other first responders. This training teaches SE Ohio officers to recognize persons in mental health crises and arrange help rather than jail. Sixteen officers/first responders were trained during November, bringing the total number trained to 415.

The Board works with Hopewell Health Centers to manage admissions, discharges and aftercare for residents admitted to Appalachian Behavioral Healthcare and other state psychiatric hospitals. Hopewell Health Centers crisis staff conducted 2849 hospital crisis screens. In state hospitals, there were 160 episodes of care for a total of 6236 patient days in SFY 2020.

The Connett Road Group Home opened in March 2020. Operated by Hopewell Health Centers, this ten-bedroom home fills a much-needed gap in the system of care.

NAMI Athens is filling a community gap by providing guardianship services for persons with serious and persistent mental illness. This program is currently very limited, but there are hopes to expand in the future as funding permits.

#### Helping Those with Substance Use Disorders-

The Overdose Response Teams in Athens and Hocking Counties continued to make friendly visits to persons treated for an overdose to check on their well-being and to encourage treatment. Board funding for a sheriff deputy in Vinton County offers response to individuals with behavioral health issues who are involved with criminal justice or child protective services.

Hocking County hosted their 8th Town Hall meeting on October 3, 2019, with nearly 100 community members in attendance. Board staff participated in the community plan developed by the Vinton County Prevention and Recovery Council. The Athens HOPE and Athens Opiate Task Force hosted a Trauma-Informed training on Wednesday, November 13, 2019 at the Mary Hill Center in Nelsonville.

#### Behavioral Health During the Pandemic-

On March 22, 2020, a stay-at-home order was issued in Ohio in response to the COVID-19 pandemic. The Board office closed to the public and most employees moved to working from home. The Board took several steps to help agencies—advancing payments for purchase of supplies, providing Personal Protective Equipment (PPE), and a partnership with the Osteopathic Heritage Foundation of Nelsonville.

Behavioral health is essential health care that serves vulnerable and at-risk populations. The 317 Board Network of Care providers quickly adopted new technologies and strategies to continue to meet community needs telehealth, smaller group sizes and use of outdoor space. Reggie


### Increasing Revenues to Address Community Needs-

In 2020, the Board received State and Federal funds from the Ohio Department of Mental Health and Addiction Services as well as two local levies.

In collaboration with our provider network, the Board was awarded State Opioid Response Federal \$1,443,575 from October 2019 thru September 2020. This funding continues opioid treatment programs, rapid access programs in all counties, peer supporter outreach services and recovery housing.

Ohio MHAS granted \$84,696 to the Board for a new Community Transition Program to help address the needs of persons released from an Ohio prison. The goal of the program is to engage them in treatment and to reduce recidivism.

Ohio MHAS awarded capital funding of \$437,375 to Sojourners Care Network for a new youth resiliency center in Athens. Ohio MHAS awarded \$371,625 in capital funding to Integrated Services for Behavioral Health for The Hive youth resiliency center in Nelsonville.

# Partnership with the Osteopathic Heritage Foundation of Nelsonville

The 317 Board and the OHFN partnership began in 2012 with a multi-year commitment to collaboratively support innovative and effective strategies designed to improve the health and quality of life for vulnerable individuals and their families affected by addiction and mental health issues. To date over two million has been committed through a 1:1 funding commitment by the partners.

In state fiscal year 2020, the following projects were completed and new investments were made to improve the well-being of children and families, and to respond to the COVID 19 pandemic. Below is a summary of this work.
