


Community Boards, Community Accountability, Community Benefits...

The 317 Board is responsible for planning, funding, and promoting quality mental health and substance use disorder services in Athens, Hocking, and Vinton counties. Its oversight of federal, state, and local monies supports a Network of Care, including 14 contracted agencies that provide prevention, treatment, crisis, and recovery supports to the community. The Board partners with courts, community coalitions, schools, and other government and non-profit organizations to assess and prioritize service needs.

In November 2021, the Board successfully renewed its 10-year, one-mill property tax levy with 64% of voters approving the ballot measure across all three counties. We deeply appreciate the community's support in this vital source of funding for mental health and addiction services in Athens, Hocking, and Vinton counties.

Helping Those in Crisis


The Ohio Department of Mental Health and Addiction Services (OhioMHAS) and the 317 Board have prioritized investments in crisis services over the past few years. As the lead for crisis services, Hopewell Health Centers served more than 3,000 individuals in Athens, Hocking, and Vinton counties during the 2022 calendar year, averaging 250 crisis responses per month.



In fall 2021, **Athens County**'s Mobile Crisis Unit pilot program was launched. The Mobile Crisis Unit pairs a licensed clinician from Hopewell with an EMT from Athens County EMS to de-escalate and respond to mental health calls. While currently only available during limited hours, there is potential for future expansion.



The Mobile Response and Stabilization Service (MRSS) was launched by Hopewell Health Centers in **Vinton** and Jackson counties in January 2022. This service provides safety assessments, deescalation, and peer support to youth ages 0 - 21 and can be contacted 24/7. This service is expanding to Athens and Hocking counties to meet local needs.



Hopewell Health Centers' crisis call center serving **Athens**, **Hocking**, **Vinton**, Gallia, Jackson, and Meigs counties became certified through the National Suicide Prevention Lifeline in preparation for the national launch of 988 in July 2022.





Thanks to funding from the HEALing Communities study, the Board was able to launch a mobile resource app – **LocalHelpNow** – in May 2022, putting crisis numbers and social services one button away from community members.

Strengthening Local Workforce

Workforce capacity is one of the biggest barriers to meeting community needs. The Board was pleased to partner with the **Osteopathic Heritage Foundation of Nelsonville** (OHFN) to strengthen the behavioral health workforce by supporting workforce recruitment and retention strategies. Through the funding partnership, a combined **\$600,000 will support seven behavioral health organizations** serving the three-county area:

In partnership with Southeast Trauma Informed Care Collaborative (SETICC,) the Board was able to fund **Eye Movement Desensitization and Reprocessing (EMDR) training for 10 clinicians** in Athens, Hocking, and Vinton counties.

The Board partnered with the **Ohio Bureau of Workers' Compensation** to enroll **eight local businesses** in the **Substance Use Recovery and Workplace Safety Program** in Athens, Hocking, and Vinton counties.

Collaborating with Partners

The following projects and initiatives took place during fiscal year 2022...



Crisis Intervention Team (CIT) training (above) resumed after being paused in 2020 due to the COVID-19 pandemic. Twenty new officers and first responders participated in 2021, bringing the total trained to more than **400 first responders** throughout the program's history.

Housing projects were prioritized using local and state capital funds:

- **\$239,750** was utilized to expand **Serenity Grove recovery home** (below) from 5 to 8 beds and make improvements to accessibility.
- **\$500,000** was allocated to renovate and maintain 53 affordable housing units at **Carpenter Hall** in Athens.



The Board partnered with the **HEALing Communities study** to invest more than **\$550,000** into naloxone distribution, resource linkage, safe prescribing and dispensing initiatives, and media campaigns related to substance use disorder.

New state funding was administered for inpatient psychiatric and **wraparound services** for adults with serious mental illness to improve outcomes.

Flexible levy funding allowed the Board to provide **\$144,000 in one-time funding** to contract agencies, health departments, and community coalitions.



In November 2021, the **Scenic Hills Senior Center** in Logan presented the Board with an award honoring the agency's dedication and aid to seniors during the COVID-19 pandemic.

The Board supplied **PPE** and COVID tests to 12 community partners and agencies to help keep staff and clients safe.
