The Board assesses service needs, contracts with local service providers and evaluates performance via achieved outcomes. The Board primarily pays for services not reimbursable by Medicaid or health insurance and/or services received by persons without health insurance coverage. The Board works with community partners to ensure that individuals and families effected by mental illness or substance use disorders have access to high-quality prevention, treatment and recovery supports.




FY 2021 Finances

Some highlights from the 2021 State Fiscal Year...

Community Education and Special Events

The Board observed the Ohio Association of County Behavioral Health Authorities' annual Week of Appreciation which celebrates frontline workers and first responders by distributing more than 1,000 notebooks with a thank you message to employees in the Board's network of care.

The 317 Board published a Facebook page in March 2021 as a new tool for community education.

The Athens County Suicide Prevention Coalition & NAMI Athens hosted a virtual Survivors of Suicide Loss Day Event on Saturday, November 21.

In September, the Board partnered with the Athens County Suicide Prevention coalition and the Gallia-Jackson-Meigs Board and suicide prevention coalitions to host the inaugural Southeast Ohio Suicide Prevention Conference virtually.

In October, The Board partnered with the Athens Racial Equity Coalition Health and Wellness Committee to host a community training on Minority Health Care in Appalachia.



The Board sent 400 Crisis Text Line magnet clips with a "healthy ways to cope" tip sheet to Hocking County's annual Kidpalooza event that was adapted to a drive-thru format.

New Initiatives

The Board awarded \$100,960 in new state funding to support the costs of the Carlson Center, a new 20-bed withdrawal management program run by Outreach and Crisis Counseling Services, LLC.

The Board entered into a contract with the Ohio Bureau of Workers Compensation to offer the Substance Use Disorder and Workplace Recovery Program to employers in Athens, Hocking, and Vinton counties. The program reimburses employers for legal review of drugfree workplace policies, staff trainings related to substance use, drug testing for prospective and current employees in recovery, and more.

The Board awarded \$2,058,275 in new federal State Opiate Response funding which supported programming at seven certified behavioral health organizations and five recovery housing programs and served 1,747 people across all programs.

COVID Disruptions

During the COVID-19 pandemic, intermittent service disruptions were inevitable when staff or clients became ill or needed to quarantine. The governing board sent a letter encouraging all contract agencies to encourage staff to vaccinate against COVID-19 to minimize service disruptions and protect vulnerable populations.

High numbers of COVID cases in 2020 and early 2021 meant that several major events were postponed. For the first time since 2003, the annual Crisis Intervention Team (CIT) training was not held in-person. The 317 Board also chose to cancel the 2020 annual meeting.

Despite these difficulties, the Board's network of care showed great resiliency Service providers pivoted to provide support for their clients in new ways – offering telehealth appointments and hosting outdoor support groups to allow for social distancing. On June 18, 2021, the risk of COVID was mitigated enough that the State of Ohio ended its emergency declaration.



The Board coordinated more than two dozen shipments and deliveries of Personal Protective Equipment (PPE) and COVID tests to agencies.

Community Partnerships

The Board approved \$300,000 to match an equal amount offered by the Osteopathic Heritage Foundation of Nelsonville (OHFN) for a new partnership to focused on youth and familyserving programs. The funding was used for:

- Hopewell Health Center's trauma-informed schools initiative in nine school districts
- New vehicles for Sojourners Care Network
- Transitional housing for My Sister's Place
- Architectural plans for the Serenity Grove recovery home expansion project

The Board partnered with Hocking County to fund part of their community health assessment and participated in the Community Health Improvement planning process in each health district.

A new crisis stakeholders group was formed with Judge Jonah Saving, and Hocking Valley Hospital, law enforcement and Hopewell Health Centers to coordinate crisis care in Hocking

Capital Investments and Infrastructure

The Board catchment area saw the opening of three projects supported with state capital grants totaling \$1,309,000

- A new location for The Hive (ISBH) in Nelsonville.
- HHC's behavioral health addition to its McArthur office
- Sojourners Youth Resiliency Center in Athens.

Board-owned properties also received improvements:

- New roof and concrete driveway at New Beginnings peer support house in McArthur.
- Foundational work to address a rain seepage issue at the John W. Clem House.
